If a student is dismissed from the program, there are no refunds.

Transportation will be provided by and take place under the guidance and supervision of employees of Epiphany Cathedral Catholic School. If you request that your child(ren) participate, please read, complete, sign and return this contract which includes your consent, as a full release of liability. As a parent or legal guardian, you remain fully responsible for any acts of the named student(s).

For and in consideration of the student(s) being allowed to participate in this program and other valuable consideration, the undersigned parent, guardian or legal representatives, on behalf of the student(s) and the student's parent, personal representatives, assigns, heirs and next of kin, do hereby accept and assume all risk associated with and inherent to the normal transportation of students and thus the undersigned release and hold harmless Epiphany Cathedral Catholic School and its employees and agent of said parties engaged in this particular program, and their personal representatives or assigns, from any loss or damage on account of any injury to the person or the personal property, of the student(s), or death, caused by negligence or otherwise, while the student(s) are engaged in the bus transportation program. The undersigned expressly agree that this release, waiver and indemnity is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that if any portion of this agreement is held invalid, it is agreed that the balance shall not withstanding, continue in full legal force and effect.
